Examples of changes could include:

- Significant alterations in business patterns such as changing the types of goods you deal in or changes in processing or storage procedures;
- Significant changes to your record keeping systems
- Any issues related to financial solvency
- Any issues related to security (appropriate to an AEOS)
- Any other significant changes to those activities declared on your application.

This authorisation letter must be kept in a safe place and made available at the request of any Officer of Revenue and Customs. The use of this authorisation is subject to the conditions laid down in the UCC and its associated Delegated Regulation 2015/2446 and Implementing Regulation 2015/2447.
